Draft Budget was handed out. The only changes were made was the Gauge Rod was taken off for 2021, \$12,000 for a flap gate. Engineering was brought down to \$10,000.00. We will have to have the outlet inspected and may have to work on piezometers. Shellie asked about any projects that may need to be included in the budget. It was decided to add more to the budget in ditch repairs.

Bryan discussed the annual meeting status. Shellie said we need to know by the first part of January, rather we can hold the meeting. We will communicate through email and make the decision.
