# MINUTES OF THE PREVIOUS MEETING:

#### **OPERATIONS:**

There was 8 inches of new snow on April 29. On May 7, they plowed snow and removed trees from Middle Hubbard to the reservoir. The reservoir was just under 25 ft. There was no ice on the reservoir. The were a lot of trees down in the ditch this spring. Today Ray and Austin road the lower ditch from Leroux Creek to the Julian. They removed several more downed trees due to the wind. There is a slide by the cabins and another one by the Julian. The flume at Oak Mesa is running 10 cfs. The upper ditch still has a lot of snow in it. They will go back up and finish opening the ditch when the snow melts and water starts running.
